#### 1) Preamble: Specific measures in relation with the COVID19 crisis 2020-2021:

Students who cannot travel due to international mobility restrictions in relation with the COVID19 crisis (flight restrictions, impossibility to obtain a VISA, etc.), or who have medical conditions who render them high risk for COVID complications (duly justified by a medical certificate), are allowed to attend classes and learning activities in a remote mode upon approval by the SMACCs consortium.

In case of delays during visa application or other problems linked to the COVID-19, students may be allowed to start their studies provisionally at home using e-learning tools until the mobility is operational again if they provide sufficient evidence in writing.

The modalities of payment of the scholarship to the scholarship holders in the particular case of the COVID19 are described in a separate document that is communicated to the student.

#### 2) Attendance

The Student commits himself/herself to duly attend the academic programme and the prescribed lectures, seminars, summer schools and examinations of the Joint MSc in Smart Cities and Communities, having a duration of two academic years, in at least three of the following programme partner Universities of the SMACCs consortium, in accordance with the programme of studies supported by the European Commission: the Université de Mons (UMONS, Belgium), the Heriot-Watt University (HWU, UK), the International Hellenic University (IHU, Greece) and the Universidad del Pais Vasco (UPV/EHU, Spain). The Student is obliged to reach the expected performance results to be allowed to continue participating in the joint programme.

#### 3) Key Elements of the Programme

- a) Duration: SMACCs is a 2-year (equivalently, 4 academic semesters) programme for a total of 120 ECTS, with each academic year nominally starting on September 1<sup>st</sup> and ending on August 31<sup>st</sup> of the following year.
- b) Structure: The program offers a combination of the students' attending course lectures, performing project work, working in internships and completing an academic thesis.
- c) Mandatory Mobility Requirements and Restrictions:
  - The students will spend the first three semesters attending courses, where each semester will be spent in a different programme University (i.e., UMONS, HWU, IHU, UPV/EHU) according to the four mobility paths shown in Table 1 below (30 ECTS/semester). The complete list of courses (compulsory and electives) offered by the four programme Universities is provided in Appendix A. In the fourth semester, the students will perform their thesis work, worth 30 ECTS, according to the options shown in Table 1. The thesis work can be performed in ANY of the three previously visited programme Universities of the followed mobility path OR in an Associated University OR in an Industrial partner/Research Institute (in the case of an Industrial partner, the term "internship" is used as a synonym for "thesis"). Each Associated University or Industrial partner/Research Institute is associated to one of the four programme Universities. Depending on the specific programme University in which the students perform their thesis, or to which their thesis is associated via an Associated University or Industrial Partner/Research Institute, the students will also obtain the specialization of that programme University.
  - Students will choose their **preferred** mobility path and **two (2) alternative** mobility paths, in order of preference, at the time of application. They will also indicate their preference for their specialization during their first year of studies. The consortium will

aim to allow students to follow their preferred mobility paths, **subject to the following restriction**: in the first semester, the students are distributed between HWU and UPV/EHU according to a 60:40 rule, namely none of the two Universities should host more than 60% or less than 40% of the year's intake. The same 60:40 rule will be applied in the second semester between UMONS and IHU and again in the third semester between HWU and UPV/EHU, respectively. In the fourth semester, when the thesis work will be performed, the students will be distributed among UMONS, HWU, IHU, UPV/EHU according to percentages of around 30%, 20%, 30%, 20%, respectively.

The students can choose to perform their thesis in any of the three Universities in their selected mobility path, **OR** in any of the following Associated Universities:

d) Additional courses offered: The programme partner Universities as well as the Associated Universities also offer extra, non-ECTS bearing courses, which the students can follow if they want to deepen their knowledge in a particular area of research. These courses may be offered, online or

through distance learning methods, in the 4th semester on a student-by-student basis depending on the courses and thesis supervision offered by the Programme University or Associated partners (Associated Universities, Industrial partners/Research Institutes) as well on as the student's interest, academic performance and language abilities.

- e) Course Languages: All courses offered by the four programme partner Universities are taught in English. If the students perform their thesis work in one of the Associated Universities, they may attend, at their choice and subject to availability, courses by the Associated Universities in languages other than English.
- f) Academic Calendar Milestones: The academic year typically starts on September 1 and ends on August 31 of the following year, taking into account the academic calendar of each of the four programme partner Universities as shown in Table 2. There is a break over the Christmas period and students also have time for summer vacation. The Summer School is held in July of each year. The participating Universities of the SMACCs consortium shall announce the final academic calendar by the first week of the academic year, including the course schedule and location as well as the examination periods. The Coordinating Institution (UMONS) in consultation with the organizing Institution shall announce the period and location of the Summer School within the first three months of each academic year. Students are encouraged, when possible, to arrive 1-2 weeks before the start of the class periods applicable to their 1<sup>st</sup> semester programme University in order to participate in possible orientation sessions, complete administrative obligations (e.g., registration, insurance, residence permit) and get acclimatized to their new environment before classes start.

- g) Welcome Week: Each programme University may host a welcome week or induction sessions for incoming postgraduate and international students.
- h) Summer School: The summer school is the main programme-related event where all students and many staff members involved in the SMACCs Master Programme meet together for a one-week period at a partner university in July. The summer school that will be linked to a conference is one of the highlights of the programme, because of the international atmosphere and the potential for networking but also due to the academic topic of the conference that is organized each time and varies from summer to summer. SMACCs students have to participate in at least one summer school, either at the end of the first academic year or the end of the second academic year in the SMACCs Master Programme
- i) Exam Periods: Examinations are held at the end of each semester in all programme Universities currently attended by the students.
- j) Thesis work: In the 4<sup>th</sup> semester, each student must work on and complete a Master thesis, which will draw upon and further specialize on subjects covered in the SMACCs programme courses. The Master thesis topics are presented to the students at the end of the first semester of courses, where all Master thesis topics are placed in a common pool upon agreement among the 4 programme Universities in collaboration with the Associated Partners. Some additional topics can nevertheless be added during the second semester, in order to include topics from

industrials partners and/or proposed by the students which may come later. All students must select their thesis topic by the 15th of April of the first academic year. The SMACCs Executive Committee can allow students to change their topic within their 2<sup>nd</sup> semester of study upon submission of a request by the student including a justification for the change.

Thesis topic selection: Each student will choose at least 5 thesis topics, in order of preference. At least two of these five choices must concern a topic mainly supervised by the university of their second semester. The student is also free, among the five thesis choices, to propose a topic on his/her own initiative, helped by the local coordinator of the university in which he/she wants to prepare the thesis. The academic suitability of the proposal will then be evaluated by the SMACCS consortium. The SMACCs consortium communicates the thesis topics attribution to the students by the 15<sup>th</sup> of May of the first Academic year. In case two or more students select the same thesis topic/internship place and there is only one place available, then purely meritocratic criteria will be applied, based on students' GPAs of the 1<sup>st</sup> Semester. Once the students have been assigned their thesis topic, they are allocated (if it is not already the case) a thesis supervisor from one of the four programme Universities proposing the thesis topic, and possibly a co-supervisor from either one of the other three partner institutions or an Associated Partner/Research Institute/Industrial partner related with the thesis project.

Thesis proposal: At the end of their first year of studies, during the exam session or during the summer school taking place in July, students present a tentative research proposal for their Master thesis in English, which counts for 3 ECTS credits out of the 30 credits allocated to the Master Thesis. This research proposal shall contain for instance the objective of the work, research questions, methodology, the initial datasets to be used (if applicable), an outline of the thesis and a bibliography. More specific guidelines for the tentative research proposal to be presented (e.g. mode of presentation: report, poster, slide presentation, contents, etc.) will be provided in due time.

Thesis submission: The thesis must be submitted in written form in English (using a specific SMACCs cover page and document template) and presented orally by the student at the end of the 4<sup>th</sup> semester. Students may adopt a theoretical or empirical approach or a combination thereof, but are encouraged to address a concrete problem related with the material taught.

- k) Specializations offered: The students will get the specialization of the programme University in which they complete 60 ECTS (i.e. one semester + thesis work) according to the following list:
  - UMONS: Specialization on Sustainable Urban Planning, Energy and Transport.
  - HWU: Specialization on Smart Grids and Demand Management.
  - IHU: Specialization on Information and Communication Technologies.
  - UPV/EHU: Specialization on Energy Efficiency on Buildings.
- 1) Degrees offered: All students will be awarded a joint degree issued by HWU. The students will also be issued a Diploma Supplement stating the specialization of the student's chosen mobility path and the official transcripts of records from all co-operating Institutions. All partners will sign off electronically the list of students to graduate for each cohort. HWU will then physically sign the diploma parchment on behalf of all partners. The diploma will bear the crests of all four programme Universities. The diploma is accompanied by an annex that lists all the courses and the thesis's title along with the credit points earned and the grades received. The accompanying diploma supplement contains the specialization obtained and more general information on the language of instruction, the institutions delivering the courses, the examination procedures, and all other relevant details such as the ECTS system.

In addition to the MSc degree in Smart Cities and Communities, SMACCs students have additional degree options (double degrees) depending on their followed mobility paths:

- i. Students who have chosen mobility path 1 or 3 (see Table 1), have been admitted with a degree in engineering or in sciences (on a case-by-case study), and have chosen their thesis under supervision of UMONS, will additionally obtain the official University degree of MSc in Mechanical Engineering with specialization in Energy Engineering (in French: Master Ingénieur civil mécanicien avec finalité en Génie Energétique) PLUS a Supplement stating the further specialization obtained at UMONS in the area of Sustainable Urban Planning, Energy and Mobility. The UMONS MSc degrees have been awarded the EUR-ACE® European quality label for engineering degree programmes and are fully recognized in Europe. They give access to the professional accreditation processes in most countries (with all the professional and legal rights).
- ii. Students who have chosen their thesis under supervision from UPV/EHU, or who decide to defend their thesis at UPV/EHU even if it is not supervised by UPV/EHU, will additionally obtain the Master in Research in Energy Efficiency and Sustainability in Industry, Transport, Construction and Town Planning (Máster Universitario en Investigación en Eficiencia Energética y Sostenibilidad en Industria, Transporte, Edificación y Urbanismo/Energia Eraginkortasun eta Jasangarritasunaren Ikerketa Industrian, Garraioan, Eraikuntzan eta Hirigintzan Unibertsitate Masterra, MREESITCTP) from UPV/EHU.
- iii. Students who choose mobility path 2 or 4 and also perform their thesis under supervision from IHU can additionally obtain the MSc in Information and Communication Technology.

The awarded degrees are shown in Table 3 below.

- m) Graduation: The Coordinating Institution (UMONS) will be responsible for the transfer of marks/examinations results to the Partner Institutions and especially to HWU for graduation purposes. Each Institution from which a student is receiving the award will provide the graduates with a transcript of marks at the fee normally charged by the Institution for this service (EMJMD scholarship students are exempt from this fee). The transcript shall contain information on the names of each of the Institutions and by which particular Institution credits have been awarded, the principal language of instruction and assessment, and the fact that each Institution is making an award based upon the credits accumulated for a single Programme. All partners will sign off electronically the list of students to graduate for each cohort. HWU will then physically sign the diploma parchment on behalf of all partners. The diploma will bear the crests of all four programme Universities. The diploma is accompanied by an annex that lists all the courses and the thesis's title along with the credit points earned and the grades received. The accompanying diploma supplement contains the specialization obtained and more general information on the language of instruction, the institutions delivering the courses, the examination procedures and all other relevant details such as the ECTS system. SMACCs graduates will be eligible to join the Alumni/Graduates Association of all partner institutions, subject to payment of an appropriate single fee where required.
- n) Graduation ceremony: The joint degree will be awarded by HWU at its normal graduation ceremonies and the degree parchments will bear the signature of the authorised signatories from HWU. This diploma will also be accompanied by the official transcripts of records from all cooperating Institutions. The graduation fee will be in line with HWU's policies and practises. EMJMD scholarship students are exempt from this fee.

#### 3) Academic Outputs

- a) The student is expected to demonstrate due diligence during his/her studies, participate in all required assessment procedures and take the examinations as required for each course attended.
- b) The student's performance will be monitored by the course lecturer(s), the SMACCs Academic Committee and the local University Academic Board, as instituted in the SMACCs consortium agreement.

- c) The student will receive course marks according to the local traditions and regulations of the University offering the course. At the start of each teaching period partner Universities provide all students with the local examination regulations. The SMACCs Academic Committee will define and issue a common framework for examination and grading for the programme's joint elements.
- d) The SMACCs curriculum is based on the ECTS system. The procedure for transfer of credits, if applicable, is as follows:
  - The university where the student effectively studied in a semester sends the obtained marks of the student to the SMACCs Coordinating Institution (UMONS); for 1<sup>st</sup>/3<sup>rd</sup> semester courses this should occur before March 15<sup>th</sup>, and for 2<sup>nd</sup> semester courses before July 30<sup>th</sup> or September 20<sup>th</sup>, in case of re-sits. For each course, the locally obtained mark and grade of each student, the total number of students following the course and the ECTS grade will be communicated.
  - The SMACCs Coordinating Institution converts the local grades to an A-F scale according to an agreed conversion table (see Appendix B) for each participating institute. This is done to facilitate the final awarding of the degree. In recognizing that each University operates its own scheme for the allocation of marks, the SMACCs Executive Committee has agreed upon a process for the calculation of equivalence of marks awarded by individual universities based on the ECTS Users' Guide 2015<sup>1</sup> and the distribution of grades in the four partner Universities as shown in Annex B (updated for each academic year). After approval by the Academic Committee, converted scores will be entered in the study management platform at UMONS.
  - At the end of each academic year, the secretariats of the partner universities will produce an official transcript of records per semester with an overview of already obtained credits. These transcripts of records will be made available to the students.
- e) If a student fails a course, as defined by the local regulations of the University offering the course, normally one resit per course will be allowed. Specifically, resits of 1st semester courses take place by July, of 2nd semester courses by September, and of 3rd semester courses by July, hosted in the partner university where the student currently studies. Students resitting a course remain bound to the examination regulations and criteria of the university where they followed the course.
- f) At the end of each academic year the Academic Committee will review the study performance status of each student and will advise them on continuation of the programme. Students who have passed successfully all the courses of their program are awarded the associated credits and are allowed to continue. In any other case, the Academic Committee will fix for each student the conditions for the continuation of the programme, on the basis of his/her examination results. Students with continuous course fails (i.e., 2 fails in a single semester; for this purpose, a course is considered to be failed, if the student also fails the resit) may be advised to end their study. Students who quit the SMACCs programme before the beginning of the 3rd semester but have successfully completed courses for a total of at least 45 out of 60 ECTS in the 1st and 2nd semester will get a certificate of attendance and transcript of records stating the courses for which they have earned credits. Students who quit the SMACCs programme before the beginning of the 4th semester but have successfully completed courses for a total of at least 75 out of 90 ECTS in the 1st, 2nd and 3rd semester will get a Postgraduate Certificate<sup>2</sup> and a transcript of records.
- g) For the master thesis, a common evaluation procedure is developed. Common standards are used and the thesis is defended before an examination commission appointed by the Academic

Committee and consisting of three academics (including the supervisor) of which one belongs to another university. The thesis can only be defended when all the necessary requirements, i.e. 1) passing all courses, 2) satisfying mobility requirements and, 3) participating in joint programme activities to obtain the degree are fulfilled so that the examination commission can recommend to the Academic Committee on awarding the degree or not.

h) The final grade of the diploma, if applicable, is decided by the Academic Committee, and communicated to the issuing university (HWU) till September 15<sup>th</sup>, which will prepare the joint diploma, accompanied by the diploma supplement.

#### 4) Participation Costs

- a) Scholarships: Scholarships are provided by the EU under the Erasmus+/EMJMD SMACCs programme, covering the full participation costs for successful applicants (tuition, administration fees, etc.), and also providing a contribution to travel costs, according to their location of residence at the time of application for the scholarship, as follows:
  - 1,000 EUR per year per scholarship holder resident in a Programme Country<sup>3</sup> for travel costs.
  - 2,000 EUR per year for travel costs + 1,000 EUR for installation costs for scholarship holder resident in a Partner Country<sup>4</sup> whose location of residence is situated at less than 4,000 km from the SMACCs Coordinating University (UMONS).
  - 3,000 EUR per year for travel costs + 1,000 EUR for installation costs for scholarship holder resident in a Partner Country whose location of residence is situated at 4,000 km or more from the SMACCs Coordinating University (UMONS).
  - 1,000 per month (for a maximum of 24 months) as a contribution towards subsistence costs.
  - The maximum total scholarship grant is 47,000 EUR per applicant.

Contribution to subsistence costs will NOT be given to scholarship holders for periods they spend in their country of residence.

Contribution to subsistence costs will NOT be given to Partner Country scholarship holders for periods exceeding 3 months spent in any Partner Country.

b) All non-scholarship students pay an annual fee to the SMACCs Secretariat, towards tuition and coordination costs. This fee amounts to 4,000 EUR per year (hence, 8,000 EUR for the 2-year programme duration) for Category A (EU) students<sup>5</sup> and 8,000 EUR per year (hence, 16,000 EUR for the 2-year programme duration) for Category B (Non-EU) students and includes free access to libraries, labs, or the Internet inside the four programme Universities or Associated Partners through which the study programme is completed. Confirmation of the tuition fees and payment deadline are communicated to the admitted students during registration at the partner university.

The programme considers as non-EU students nationals of a third country other than those from a Member State of the European Union or non-long-term residents of any of the Member States.

- c) For non-scholarship students, the costs of travelling and accommodation, which must be compulsorily achieved after student mobility within the SMACCs consortium, will be at students' own responsibility. Thus, non-scholarship students are expected to cover their travel and accommodation expenses during their study stay. However, the SMACCs consortium will exert special efforts to support students' applications for official fellowships. While no university tuition fees are charged at Associated Partner universities, students may incur small administrative fees from some partner universities that may charge an additional fee for exam and/or thesis registration as well as diploma delivery.
- d) Language Course fees: Students interested in taking a preparatory language course during their first or second academic year (at UMONS in French, at UPV/EHU in Spanish or Basque, at HWU in English and at IHU in Greek) can sign up for a multiple-week intensive course (payable to all Universities) prior to the semester start or a regular course (with a fee or not depending, on the University). Any fees incurred are payable to the individual universities and are NOT part of tuition fees. Students are not required to take such a language course, but are being advised for it. The eventual language course fees are paid directly to the organizing institution upon signing up for the language course.
- e) Summer School fees: The summer school is the main programme-related event where all students and many staff members involved in the SMACCs Master Programme meet together for a one-week period at a partner university in July. SMACCs students have to participate in at least one summer school, either at the end of the first academic year or the end of the second academic year in the SMACCs Master Programme.
- f) Additional fees: students may also incur administrative expenses related to application documents, visas, residence permits, and graduation fees. Such expenses are not included in the university tuition fees. The issuance of the additional diplomas referred to in Article 2 (item k) will be subject to the payment of the fees in force in the corresponding University

#### 5) Financial Aspects

- a) The monthly allowances of the scholarship for subsistence costs are paid by the Coordinating Institution to the Student in monthly instalments of 1,000 Euros each for a maximum of 24 months.
- b) The contribution to travel payment as described in Article 4 will be paid to the students at the beginning of each academic year. The installation grant will be paid to students at the start of the first academic year. These payments will commence up to 30 days after the beginning of the academic year but not before the end of the registration process at the first host University and the signature of the student agreement. These payments are made by bank transfer to the Student's personal bank account, details of which must be provided at time of registration.
- c) The scholarship does not create or entitle an employer-employee relation between the host Universities and the Student, and therefore is not subject to direct taxation.
- d) The student is not entitled to embark on any vocational occupation with a regular salary in parallel to the studies under the SMACCs Erasmus Mundus Masters Programme. Note that a student internship, if paid, is regarded as part of the Programme.
- e) In case of exclusion or withdrawal of the Student from the SMACCs Erasmus Mundus Master Programme, on his/her own decision or force majeure, the Student hereby makes a commitment on his/her honour to reimburse the Coordinating Institution the excess funding from the scholarship allocated to him/her, which consists in any funds of the scholarship received in terms of monthly allowances covering the period following the months of the date of exclusion or withdrawal.

- f) Upon exclusion or withdrawal, the Student shall in due time and before his/her departure pay for all his/her financial obligations, in particular:
  - the rent of his/her accommodation,
  - the bank fees corresponding to his/her accommodation insurance,
  - the bank charges to pay for any of his/her bank accounts and credit cards.
- g) For the student's information, agreement between the Coordinating Institution and EACEA which funds the SMACCs programme, imposes upon the Coordinating Institution, following the exclusion or the withdrawal of students during the programme:
  - to gather the remaining funds of the scholarships allocated to such students in order to form new full scholarship(s), which will be allocated to the suitable student(s) of the next intake;
  - to refund the EACEA of the Commission of the European Communities with these full scholarship(s) if no new applicant is enrolled as a replacement.

#### 6) Health Insurance

A mandatory health insurance scheme will be provided by the consortium to all enrolled EMJMD students, in accordance with the EMJMD guidelines "Minimum requirements for the Health and Accident Insurance coverage of Erasmus Mundus Joint Master Degrees students".

- Coverage: worldwide travel required for participation to EMJMD and all-risks (as listed in the EMJMD guidelines "Minimum Requirements for Health and Accident Insurance Cover").
- Duration: coverage takes effect by the time the EMJMD scholarship holder starts his/her journey to participate in the Master course (maximum two months prior to the start of the specific EMJMD intake to which the grantee is enrolled) and must be valid until two months after the end<sup>6</sup> of the same intake, unless there is a prior end to the EMJMD grantee status<sup>7</sup>.
- Conditions: non-deductible. Non-permanent and non-chronic mental disorders will not be accepted as exclusions.
- Risks covered: as listed in the EMJMD guidelines "Minimum Requirements for Health and Accident Insurance Cover".

#### 7) Student Services

Common student services are provided locally by all consortium partners (e.g. administrative support by International Office, academic tutoring/mentoring mechanisms, local language courses, access to on-site and online learning facilities).

#### 8) Participation in Evaluation and the EMA

The student agrees to participate in the EMJMD programme surveys/evaluations. The student also agrees to join the Erasmus Mundus Students and Alumni Association (EMA, see http://www.ema.eu/).

#### 9) Code of Conduct

- a) Attendance of the academic programme and the prescribed lectures, seminars, summer sessions and examinations is recognised by the respective Universities as an integral part of the qualification for which the Student is preparing, and remains so, as long as the Student is successful in the respective examinations and/or assessments.
- b) It is the responsibility of the students to ensure that they familiarise themselves with any course work missed should they be unable, for any reason, to arrive in time for the commencement of the Programme. Arrangements should be made, by the student, with lecturers regarding any missed continuous assessments to ensure all course work is covered. Students are not permitted to use late arrival to the Programme as grounds to appeal grades awarded by the University Examination Board or Consortium Examination Board.
- c) The Student is obliged:
  - to participate in the orientation and welcome meetings as well as any informative and official meetings and events;
  - to attend assiduously, and with the objective of successfully passing, the courses, seminars, summer sessions and the thesis inherent in the programme of studies;
  - to refuse any other scholarship or subvention financed by the Commission of the European Communities under other Community programmes.

- d) Any deliberate failure on the part of the student to fulfil the conditions expected in terms of attendance at the SMACCs Erasmus Mundus Master Programme, in particular non-fulfilment of the conditions stipulated in the present Agreement and each University's Student Handbook, constitutes sufficient reason for action to be taken towards resolving the issue and could lead to the exclusion of the Student from the SMACCs Erasmus Mundus Masters Programme and the reimbursement of any scholarship awarded.
- e) An academic calendar will be made available to all students at registration. To ensure payment of scholarship funds, students are required to be in attendance at all required times as listed in the academic calendar. Students are expected to attend all lectures and a minimum of 80% attendance is required.
- f) The academic programme also includes periods of project work where there are no formal lectures to attend. During this time students are required to be in regular contact with their Project Supervisors. In the case of extraordinary personal circumstances, which require the Student to be absent from campus, documentation must be provided to explain the absence and to convince the EACEA, Visa Authorities and University staff that measures have been put in place to fulfil the student's programme requirements. Should the student be absent for any period of required time, without extenuating circumstances or prior permission, it will be assumed that the student has left the programme by their own volition and as a result scholarship payments will be suspended indefinitely from the first date of absence. A decision regarding the reinstatement of scholarship payments will only occur if/when the student returns to the University and the circumstances of the absence have been reviewed and approved by the relevant Programme Coordinator.
- g) It is essential that all students attend the Summer School. If students are unable to attend the summer school due to personal circumstances (illness, bereavement etc.) they will be asked to take part via video conference. Students will have to request special permission in this case and have documentation to back up their circumstances.
- h) All work submitted by the student is marked on the assumption that it is the work of the student as prescribed by the respective instructors/supervisors. The SMACCs consortium takes a very serious view towards plagiarism, fraudulent work, data fabrication and academic malpractice and will act to ensure that students found responsible for the above actions are held accountable. Any of the above actions may lead to grade penalties imposed by the Academic Board of the University offering the course or thesis. In cases of gross academic misconduct, which is deemed harmful to the prestige of the Erasmus Mundus Joint Master Degree in SMACCs, any involved students will appear before the SMACCs Academic Committee to account for their actions and, if found guilty of the above, may be expelled from the Programme without any degree or diploma being awarded.
- i) When an alleged offence, of a non-academic nature, is committed by a student within the precincts of an Institution, the code of discipline of that Institution will normally apply. In such cases, there will be consultation between the Institutions to ensure a consistent approach to discipline offences wherever possible.

#### 12) Administrative Requirements

- a) The student is obliged to obtain his/her residence permit from the national and local Authorities upon his/her arrival in the host countries if required.
- b) The Consortium is obliged to provide the student with the necessary support to facilitate his or her mobility to, and installation in the different hosting Universities.
- c) Scholarship students will be required to open a bank account, if they don't already have one, in the country of the first programme University they visit in order to receive their scholarship.

#### 14) General Terms

- a) Any alteration to the present Agreement or respective Annexes must be communicated in writing. All alterations to the initial situation must be immediately communicated by the Student to the Coordinating Institution and the host Universities. Upon mutual agreement of contractual modifications, the Coordinating Institution issues an *addendum* to the present Agreement.
- b) Without prejudice to the general consequences laid down in national law applicable in the present Agreement, the Coordinating Institution reserves the right to cease the effects of the present Agreement, without recourse to any juridical procedure apart from adequate communication to the Student. Failing agreement by both parts, the Swiss courts are designated as the only competent authorities to resolve any legal dispute between the Coordinating Institution and the Student emerging from the present Agreement.
- c) The Coordinating Institution and the participating Universities are exonerated from any responsibility for accidents, illnesses, injuries, losses or damages to persons or goods resulting from or in any way related to the activities that are the object of the present Agreement. The Student is obliged to accept the necessary insurance related to the activities for the full duration of the study period.



- Student Y starts at UMONS and receives a mark of 17.9, corresponding to grade "B". According to the conversion table, Student Y is within the top 20% of UMONS' cohort, so this will be converted to a "A" grade for SMACCs.
